1- CALL OF PRESENT MEMBERS, VERIFICATION OF PROXIES

At 3pm, 50 members of the association Aïkido Harmonie were present.

47 in person, 3 proxies.

The quorum is reached.

President Gilles Rettel opens the session of the ordinary general assembly by welcoming Mr. Alexandre Cozza and Jean Pierre Lacroix.

2- APPROVAL OF THE 28/08/2014 GENERAL ASSEMBLY REPORT

Lecture is made by Gilles Rettel. The Summary was published on the association's website (member's area).

The report is unanimously approved by the present members.

3- MORAL REPORT BY Gilles RETTEL

In 2014, the seminar in Le Vigan, which stays the principal activity of the association, welcomed 214 participants (222 in 2013):

- Full Seminar: 172;
- Week end or 2 days: 11;
- 3 or 4 days: 31.

Aikido Harmonie members: 65 (63 in 2013)

The 2014 General Assembly elected a new board. The main difficulty of our association is that we meet only once a year. Setting up a new organization was not an easy task.

I'd like to kindly thank Julien Bert Latrille that took care of the administrative aspect:

Web updates, payments, control system, members support, mailing, search of the music band for the party, etc.

The report is unanimously approved by the present members.

4- FINANCIAL REPORT BY Gilles RETTEL

Documents established from the accounting firm FIDUCIAL for 2014 were uploaded on the website and shared with our members.

Financial results: Surplus of 243,24 euros in 2014

Current situation:

Livret A: 78266,85 euros. Compte courant: 11797,20 euros. Caisse: 41 euros.

A debate starts on the inconsistency of the results format by FIDUCIAL.

The report is unanimously approved by the present members.

5- SUMMARY OF ALL ACTIVITIES IN 2015

For this 25th Seminar, we regret Master Saotome's absence.

However Stéphane Le Derf met Saotome Sensei and offered him the weapon stand in the name

Aïkido Harmonie during the celebration of his 40 years in United States.

The weapons stand was presented on the last day of the « ASU Summer Intensive Seminar » in Washington DC.

Stéphane informs us that Master Saotome cannot make long trips at his age of 78 years old, but he misses Le Vigan and Aikido Harmonie's members a lot.

Membership appraisal for 2015

We registered 106 membership requests this year, 22 of them from foreigners.

Budget 2015 (provisory)

Provisory result for this year is - 8 114 €.

Biggest expenses are:

- 4 840 € for the video,
- 3 700 € for the party,
- 1 023 € insurances.

Besides the exceptional expenses due to our 25th anniversary celebration, the budget 2015 is balanced.

Summary of the innovations for 2015

- Registration at the door,
- · Inviting three vendors in replacement of Déclic Aïkido,

- The T-Shirts is a project managed by Stéphane, who obtained Saotome Sensei's agreement to use his calligraphies and his autograph,
- Logo of the community council of Le Vigan was added on several supports: kakemono, diaporama, flyer,
- Filming of a video by David Charpentier to help to promote the seminar and the association,
- Three insurance contracts:
 - Public liability of the association,
 - For the participants on the mats,
 - For the party location and the music band.

6- OTHER MATTERS

 Guy Cholet asks if the seminar shouldn't be added on official calendars of the federation's comities.

Gilles Rettel answers that each comity: Gard, Hérault, etc. is free to share the dates on their calendars.

Michaela Fernandez adds that she requested it several times but the seminar wasn't added the calendar.

- Philippe Néri thanks the organization and reactivity of the board to solve his inscriptions problems.
- Luc Sandjivy also compliments the organization and underlines the unique opportunity offered by this seminar to share the teaching of Saotome Sensei and now Ikeda Sensei. That's his main motivation to be part of our association.

A debate starts around the sense of being a member of the association

Irène Lecoq concludes: « Being a member you endorse the goal of the association and the work of the members. »

- Stéphane Le Derf and Julien Bert Latrille incite the members to share the flyers, the Facebook page and events to a maximum of persons.
- François Lacombe compliments the association for the choice of the music band for the party. Nathalie Poupon regrets that it took so long to get in at the party, but admits that it was a success and congratulates the association.

Marie Paule Schwartz asks if we could organize a yearly party.

The board answers that they would rather keep it as a special event as people might be bored of a yearly party.

Looking at the success and the high demand, the board will think of an alternative to the party, like a bigger promotion of the picnic.

Michaela Fernandez asks if we shouldn't contact the Mayor in that case. Alexandre Cozza insures that a phone call is sufficient to announce the event.

• Nathalie Poupon complained that the women T-shirts were small fitted. Stéphane indicates that they are standard sized, but regrets that some women weren't satisfied.

He also started a pole about the sweat shirts models, only 15/50 said they would prefer a hoodie.

• Marc Tabourot informs the board that the lobby is small for the shops and that only one day for each seller is very short.

Stéphane answers that the main interest is to discover different craftsmen and their products, that anyone can contact them afterwards. There is no plan to change the way it's done for next year.

• Guy Cholet deplores the lack of communication inside the city of Le Vigan itself.

Julien Bert Latrille explains that the seminar is present on the LED billboards in the city center. Alexandre Cozza adds that there is a newspaper published every six months and that they could add some press info about the seminar.

These are initiatives that could be done for 2016.

• The representative of the city council Jean-Pierre Lacroix concludes the session by emphasizing how much the seminar is important to the region and how much it contributes to the economic development of the region.

7- POSSIBLE ACTION ITEMS FOR 2016

- · Press info.
- · Renew the association status.
- · Relax the control at the door.
- Changing Bank

The board indicates that they understood the problems for the foreigners to bring their weapons. The main problem is the cost it represents for them. Bringing weapons by plane costs around 180\$.

Two solutions were proposed to the assembly:

- 1. Renting some weapons,
- 2. The association takes care of storage to allow the weapons to stay in Le Vigan.

The second solution has the preference of the board at the moment.

The next seminar will be from 20 to 28 August 2016.

The General Assembly is closed at 4:30pm.
